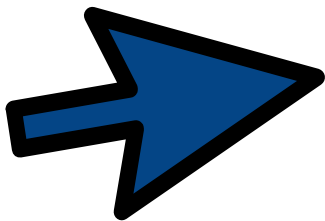
Affiliated unions are welcome to submit resolutions. These must be sent to the general secretary of the federation at least three weeks before the opening date of the convention, i.e. May 6, 2024, in accordance with article 3.10 of the Fédération du Commerce (CSN) Constitution and Bylaws.

Furthermore, please note that unions wishing to make amendments to the Constitution and Bylaws of the Fédération du Commerce (CSN) must forward such amendments to the General Secretary of the federation **six weeks** prior to the opening date of the convention, as stipulated in article 11.2 of the present Constitution and Bylaws. The deadline for such amendments is **April 15, 2024**.

**May 6, 2024 :** Deadline to submit resolutions
